was, however, collected on mother-tongue and secondary language of every person enumerated at the Census. While every person was permitted to return two languages as secondary language in case he had more than one secondary language, the tabulation was done only with reference to the first return under secondary language. The following statement gives the number of persons in the State of Punjab who have returned their mother-tongue or secondary language as Hindi or Punjabi. The figures given in the statement are provisional.
