THE MINISTER WITHOUT PORTFOLIO (SHRI LAL BAHADUR): Sir, our position in regard to this matter has been made absolutely clear in the Security Council through the statements made by my colleague, Mr. Chagla. I would not like to go into further details. I might merely say that what has appeared is only a press report, if I might not use the words *press speculation'. Still as this question has been raised, I personally feel that what I have said shnu'd be considered sufficient and perhaps the House need not waste its time over another statement to be made again. I personally feel that our position, the position of the Government of India, is absolutely clear in this matter and we cannot deviate from that position for a moment.
