RECORDS OF JAIL AT POUT BLAIR

- •215. SHRI KRISHAN DUTT: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it is a fact that all the records of the historic jail at Port Blair in the. Andamans were destroyed when the Islands, were bombed by the Japanese in 1942; and
- (b) if so, whether Government have any proposal under consideration to re-construct the history of tho jail?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI L. N. MISHRA): All the records of the Administration including those of the historic jail were destroyed during the period of the Japanese occupation of the Islands between March 1942 and October, 1945.

Some names and other particulars of the political prisoners who were imprisoned! in the Cellular jail have been collected and it is proposed to put up a plaque with their names on the Central tower for the jail to serve as a memorial

SHRI KRISHAN DUTT: May I know, Sir, who were the heroes of the national freedom struggle who were imprisoned in that jail during the freedom movement days?

SHRI L. N. MISHRA: It is a :ong list but I can give a few names. These ar_e Shri V. D. Savarkar, Shri G. D. Savarkar and a number of other names, about thirty or forty.

MR. CHAIRMAN: The hon. Member says that itf the list is a long one, will you lay it on the Table of the House.

SHRI L. N. MISHRA: Yes, Sir.

SHRI BHUPESH GUPTA: May I know, Sir, whether the hon. Minister

is aware that the Vice-President of India visited the Port Blair jail and made enquiries about the patriots who suffered imprisonment there and whether, following that visit, the Government made enquiries on its own from various sources in order to compile a list of those who spent their time in the jail and whether they have taken necessary steps in order to commemorate them in a proper way?

SHRI L. N. MISHRA: Yes, Sir, you in the capacity of the VicerPresident of India visited the island! which has helped the Government, and the Home Ministry has written to the Chief Ministers asking for the particulars of the people who were sent to the Andamans. So far we have received lists from four States giving names of 310 patriots who were there. We are expecting replies from the other States.

DR. NIHAR RANJAN RAY: May I know, Sir, whether it is not a fact that copies of most of the judgments that were traced in the Port Blair jail are available in the National Archives? Personally I have consulted some of them.

SHRI L. N. MISHRA: They must be there.

SHRI A. M. TARIQ: May I know, Sir, whether the Government is aware of the fact that some of the prisoners in the jail there have written some private diaries. Some of them have already been published in Pakistan. May I know, Sir, whether the Home Minister has taken notice of it?

SHRI L. N. MISHRA: I am not aware of it. I take the information.

SHRI BHUPESH GUPTA: Sir, even when they were in the jail there some very notable struggles took place by way of hunger strikes and so on, and they fought the authorities there. They are contained in the record*
