**APPOINTMENT OF DIRECTOR IN THE

(b) if so, how many names were considered for this appointment, and who recommended these names; and

(c) what was the constitution of the Selection Committee, and who recommended the names of the members of the selection Committee?

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION (SHRI MONO MOHAN DAS): (a) Yes, Sir.

(b) Six, who were recommended by the Director-General after informal consultation with experts in the field.

(c) In accordance with the decision of the Governing Body of the C.S.I.R., a 'Core' Committee has been appoint-

ed for selecting Directors of National Laboratories. Experts in the particular field to which a post may relate are co-opted. The 'Core' Committee comprises the following:

- (1) Dr. D. S. Kothari—*Member*.
- (2) Prof. S. R. Palit—*Member*.
- (3) Dr. Satish Dhawan—*Member*.
- (4) Director-General Scientific and Industrial Research—*Member*.
- (5) Secretary, CSIR—*Member*.

The Vice-President, C.S.I.R. is the Chairman of the Committee and Financial Adviser to C.S.I.R. an *ex-officio* member.
