published in the Hindustan *Times* of tod April, 1964, to the effect that the Department of Immigration and Emigration of Ceylon has announced an inducement scheme under which persons of Indian origin who would be willing to leave Ceylon lor good will be paid *ex-gratia* payment of Rs. 1000; and

(b) if so, whether Government have ascertained the nature of the scheme from the Indian High Commissioner in Ceylon, and what are the details of the same?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DINESH SINGH): (a) Yes Sir; the Government have seen a news-item on this subject.

(b) The details of the scheme have been ascertained. The Government of Ceylon are offering a repatriation allowance to every Indian, who, with his family, leaves Ceylon for good, subject to certain conditions. The amount of repatriation allowance payable depends on the age of the person concerned and the number of his dependents. The maximum amount pay-ble is Rs. 1000.

INDIANS IN ZANZIBAR

- *238. SHRI J. H. JOSHI: Will the PRIME MINISTER be pleased to state:
- (a) whether Government are aware that the property of some Indians residing in Zanzibar, has recently been seized by the Government of Zanzibar;
- (b) if so, what is the amount of property involved; and
- (c) whether the members of the Indian Embassy at Nairobi render any advice to the Indians living in Zanzibar?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DINESH SINGH): (a) and (b) The former Government of Zanzibar had promulgated (a Presidential de-

cree providing for the confiscation of any property when it appeared to the President that it would be in the national interest and the acquisition of such property without compensation would not cause undue hardship to the owner thereof. No reports as to the effect of this decree in actual application have yet been received.

(c) Yes, Sir. The officers of the High Commission in Nairobi have visited Zanzibar on several occasions for this purpose.
