

MISSING IAF ILYUSHIN

125. SHRI R. S. KHANDEKAR: Will the Minister of DEFENCE be pleased to state:

(a) whether any wreckage of the missing IAF Illushin has been found; and

(b) if not, whether the search is still being continued?

THE MINISTER OF DEFENCE (SHRI Y. B. CHAVAN): (a) and (b) Despite extensive efforts, including 132 air sorties from the 18th February to the 29th April 1964, the missing aircraft has not been located. The search is continuing.

IMPORT AND PRODUCTION OF ARMS AND AMMUNITIONS USED FOR SPORTS
