

*Details of cases in respect of  
Maharashtra*

(1) One Velji Monji Shah was sentenced to pay a fine of Rs. 300 or in default to undergo rigorous imprisonment for 3 months. He was prosecuted for selling imitation 'Flit'.

(2) Kaikashroo Bomanshah Bhagat, Prop. of M/s. Verona Trading Company, Bombay was convicted for manufacturing drugs without a licence and for manufacturing for

sale misbranded drugs as the licence number quoted was fictitious. He was sentenced to pay a fine of Rs. 3,000 or in default to undergo rigorous imprisonment.

(3) One Durlabdas Kalidas of Bombay was convicted for stocking for sale drugs without a licence and drugs which were not labelled in the prescribed manner and was sentenced to pay a fine of Rs. 500 or in default 3 months' rigorous imprisonment.

**BARRAGE ACROSS THE RIVER JAMUNA**

\*268. **SHRI JOGENDRA SINGH:**  
Will the Minister of IRRIGATION AND POWER be pleased to state:

(a) whether a barrage near Raj-ghat Samadhi across the river Jamuna was planned by Government about 1941 to ensure the steady supply of filtered water not only to

Delhi but also to power stations; and

(b) if so, why the scheme was given up and whether Government will consider its revival?

**THE MINISTER OF IRRIGATION AND POWER (DR. K. L. RAO):** (a) Yes, Sir.

(b) In the past it was considered enough to construct a revetted embankment along the right bank of the river for a length of about 2400 ft. near the Delhi Gate Pumping Station to attract the river to the right side. Actual experience indicated that this was not enough. A barrage in the reach near 'C' Station is under construction.

#### SOCIAL SECURITY PROGRAMME

\*270. SHRI SITARAM JAIPURIA: Will the Minister of FINANCE be pleased to state:

(a) whether there is any proposal under Government's consideration for launching a social security programme for the entire population of the country;

(b) if so, the details of the scheme and the amount involved therein; and

(c) when it is proposed to be implemented?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRIMATI TARKESHWARI SINHA): (a) No, Sir.

(b) if so, whether Government have taken any steps to ascertain the truth and to find out the details of the above report?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH (DR. D. S. RAJU): (a) Yes, Sir.

(b) The details of the reported discovery have been called from our Embassy in Moscow.

#### L.I.C. DIVISIONAL OFFICE AT CUTTACK

\*277. SHRIMATI NANDINI SATPATHY: Will the Minister of FINANCE be pleased to state:

(a) whether Government have received any protest from the Government of Orissa against shifting of the Divisional Office of the Life Insurance Corporation from Cuttack to some other place outside Orissa; and

(b) if so, what action is being taken in the matter?

THE MINISTER OF PLANNING (SHRI B. R. BHAGAT): (a) No. There is no proposal, however, to shift the existing Divisional Office at Cuttack. According to the reorganisation scheme, only a portion of the work which is now being done in that office is likely to be transferred to some other office.
