**ORAL ANSWERS TO QUESTIONS****SPORTS STADIUM IN CALCUTTA MAIDAN**

1. SHRI RAMPRASANNA RAY: Will the Minister of DEFENCE be pleased to state:

(a) whether the Government of West Bengal have approached the Government of India for the release of land at the Calcutta Maidan for construction of a sports stadium; and

(b) if so, what decision Government have taken in the matter?

THE DEPUTY MINISTER IN THE MINISTRY OF DEFENCE (SHRI D. R. CHAVAN): (a) Yes, Sir.

(ti) The Government of India had agreed to hand over possession of the land measuring 22, 772 acres to the Government of West Bengal out of Calcutta Maidan for the construct on of a stadium, pending settlement of terms and conditions.

The question was linked to certain other matters relating to Calcutta Maidan which were under consideration when the situation radically changed on our Northern borders and the matter, therefore, was kept in abeyance.

We have recently received a communication from the West Bengal Government in this connection and it is hoped that an early decision will now be taken.

SHRI RAMPRASANNA RAY: May I know the exact location of the plot which is likely to be transferred to the Government of West Bengal for construction of the stadium.

SHRI D. R. CHAVAN: It is a part of the Calcutta Maidan and it will be very difficult to give the exact location. It is a big ground.

SHRI B. K. GAIKWAD: May I know whether the Government is aware that lakhs of people are homeless in Calcutta? Will the Government consider giving this land to those who are homeless, for houses?

SHRI D. R. CHAVAN: This land is meant for the purpose of a stadium. In view of the present emergency, I do not think we would be in a position to give that land for houses.

SHRI P. L. KUREEL UR TALIB: Who will control this stadium, whether the Indian Sports Council or the State Sports Council?

SHRI D. R. CHAVAN: The demand was made by the West Bengal Government for the construction of this stadium and these are matters of detail. I have to hold discussions with the persons. I would not be in a position to give this information.

SHRI NIREN GHOSH: May I know whether certain vested interests in the sports world have so long obstructed the acquiring of land and the establishment of a sports stadium in Calcutta and numerous reports also appeared in the press? May I know whether the Government is aware of that and, if so, whether they will take early steps so that the stadium can be built?

SHRI K. RAGHU RAMAIAH: There is no question of vested interests here. The matter is one of correspondence between the West Bengal Government and the Government of India and various details are to be worked out. We are not aware of any vested interests coming in the way.

SHRI A. D. MANI: The Deputy Minister referred to the terms and conditions. I would ask him whether the Government is going to demand market rates for the land which is going to be given or is it going to give the land at concessional rates in view of the fact that a sports stadium is involved in this matter?

SHRI D. R. CHAVAN: The land would be given on lease on a nominal price of Re. 1 per annum.

SHRI EBRAHIM SULAIMAN SATT: May I know whether there is no other stadium in Calcutta, and if there is, why is this land required now when there is emergency in the country?

SHRI D. R. CHAVAN: It is the de-manc' coming from the West Bengal Government itself.

#### TRAINING IN OPERATION OF SUBMARINES

♦2. SHRI BIREN ROY: Will the Minister of DEFENCE be pleased to refer to the answer given to Unstarred Question No. 1 in the Rajya Sabha on the 11th February, 1964 and state:

(a) whether Government have since finalised plans to acquire from some friendly sources a 'submarine' suitable to train submarine operating crews for coastal defence; and

(b) whether as a preliminary step to the acquisition of a submarine, Government propose to get some naval cadets trained abroad in the operation of submarines and other modern vessels for under-sea operations?

THE DEPUTY MINISTER IN THE MINISTRY OF DEFENCE (SHRI D. R. CHAVAN): (a) No, Sir.

(b) Some officers and sailors have been trained in submarines in the U.K. and some others are at present under training.

SHRI BIREN ROY: Is the Minister aware that Pakistan is already in possession of submarines from the U.S. Arms Aid?

SHRI D. R. CHAVAN: We are not aware.

SHRI BIREN ROY: If he was not aware, is it a fact that the U.S. Government is giving arms aid to India on the condition that these are not utilised against Pakistan and with the fact that Pakistan is operating submarines at the present moment, what is the purpose of this submarine and against whom U.K., USA or China, is it going to be used in the high seas?

SHRI D. R. CHAVAN: I have already stated that we have no information about Pakistan.

MR. CHAIRMAN: You cannot ask him about things he does not know.

SHRI BIREN ROY: The Government has no information about Pakistan \_\_\_\_\_

MR. CHAIRMAN: That is what he says.

SHRI BIREN ROY: Has India got enough aircraft which are fitted with depth charges or which can be fitted with depth charges to protect our coastal shipping from being attacked by the submarines?

SHRI K. RAGHU RAMAIAH: It is a matter of operational detail which I am sure the House would not like to discuss here.

SHRI ARJUN ARORA: What is the purpose and justification of the training of the crew in the United Kingdom when the Government does not have a submarine and does not see any change of acquiring one in the near future?

SHRI D. R. CHAVAN: It is at the preliminary stage. If We intend acquiring submarines, it is necessary that our crew should be trained.

SHRI A. D. MANI: I would like to ask the Minister whether any approach has been made to friendly Governments for the acquisition of submarines on deferred payment or on any other basis.

SHRI K. RAGHU RAMAIAH: As already announced by the, Defence Minister, the Government are considering the question

SHRI N. SRI RAMA REDDY: I would like to know if in view of the great importance of submarines whether the Defence Department is thinking of manufacturing the submarines. In today's paper it is reported that the hon. Minister Shri Y. B. Chavan, spoke about the necessity of acquiring
