

निकाला करती थी। युद्ध के समय प्रकाशनों पर लगाए गए प्रतिबन्धों के कारण वैज्ञानिक प्रकाशनों सम्बन्धी छपाई का काफी काम जमा हो गया था और उनके प्रकाशन का कार्य विभिन्न प्रकाशनों के लिए निश्चित प्राथमिकता के आधार पर हाथ में लिया गया था। अतः समीक्षा का प्रकाशन कुछ समय के लिए रुक गया था।

खनिज संरक्षण और विकास नियम १९५५ के प्रचालन (promulgation) के पश्चात्, भारतीय भूवैज्ञानिक सर्वेक्षण संस्था ने इस का प्रकाशन बन्द कर दिया है और भारतीय खान ब्यूरो वार्षिक रूप से, १९५५ से १९५८ तक "भारत में खनिज उत्पादन" और १९५९ से आगे "भारतीय खनिज वार्षिक पुस्तक" का प्रकाशन कर रहा है।

t[THE DEPUTY MINISTER IN THE MINISTRY OF STEEL, MINES AND HEAVY ENGINEERING (SHRI P. C. SETHI) : The issue was released in 1962. Prior to 1955, the Geological Survey of India was bringing out Reviews on the Mineral Production of India. During the war due to ban on publications, printing work relating to a large number of scientific publications had accumulated and was taken in hand for clearance, according to the priorities assigned to the various publications. Thus, the publication of the Review was held up for some time.

After the promulgation of the Mineral Conservation and Development Rules, 1955, the Geological Survey of India has discontinued the publication and the Indian Bureau of Mines has been publishing annually "The Mineral Production in India" from 1955 to 1958 and "The Indian Mineral Year Book" from 1959 onwards.]
