During the periods of stoppages of work as well as the shut-down of the plant lasting from 18th March to 17th April, 1964, the Plant incurred an estimated loss of Rs. 100 lakhs of production, which worked out to an aver, age daily loss of about Rs. 4 lakhs.

The ring leaders behind the labour unrest have been already arrested under the provisions of Defence of India Rules and Criminal Procedure Code. Other disciplinary measures are under consideration.
