fidence and tell us they have a programme which will be completed, say, within two years, three years, within some definite period?

SHRI A. B. VAJPAYEE: They have 110 programme at all.

MK. CHAIRMAN: The Minister has said that he will do it as expeditiously as possible.

SHRI G. RAMACHANDRAN; All this heat and indignation comes because there is so much delay. I personally do not think it is a very important thing—where the statues are —but if they are to be removed, why can't the Government take us into confidence and say that within two years, three years or four years they will remove them.

Mr. CHAIRMAN: They can't take you into confidence because they themselves don't know.

SHRI L. N. MISHRA: As I said we will not take long but We cannot give any definite time limit. It won't be two or three years it will be much earlier.

SHRI M. C. CHAGLA: Well, Sir, there have been certain findings by thi_s unit that we have set up but there has not been yet a formal Report.

SHRI N. SRI RAMA REDDY: What are the main features of the findings made by this study team?

SHRI M. C. CHAGLA.- The findings are rather detailed. This unit con sidered three main questions: (1) the proportion of recurring research expenditure on different items, their trend and the relation of recurring to capital expenditure; (2) trend of expenditure on some of the auxiliary ser vices; and (3) trend of cost per scien tist and the structure of cost per scien tist.

SHRI M. S. GURUPADA SWAMY: May I know whether the attention of the hon. Minister has been drawn to a report today about the opinion of a Professor who has told certain M.Ps yesterday here that there is too much of politics, too much interplay of politics in the National Laboratories and no research as such was being undertaken and, if so, may I know whether any steps are being taken by the Ministry to weed out politics and political elements and political considerations from these Laboratories?

SHRI M. C. CHAGLA: I am sorry to say I find politics in every sphere of our life but the one place where there is less politics is our Laboratories.

SHRI N. SRI RAMA REDDY: I want to know at what rate expenditure in these laboratories has been increasing and whether the quantity of the work turned out has been having any relation to the expenditure incurred during these few years.

SHRI M. C. CHAGLA; Well, Sir, expenditure has increased considerably and results also have been very great. Research has increased; more projects

have been put through, more assistance has been given to the industry. I might mention to the House flat I am trying to have a brochure published ana circulated to Members of Parliament to tell them of the great work our laboratories have done since their inception. So the House will know what work has been done.

Shhi B. K. P. SINHA: May I know •when this planning unit was sei up, in which year, what amount was budgeted for it last year and what amount has been provided for ii in ithis year's Budget?

SHRI SANTOKH SINGH May I know the number of projects in the case of which the results of the research work done in the various abo-ratories have been handed over 'to the . entrepreneurs in the country for commercialisation?

SHRI M. C. CHAGLA: I am afraid I did not catch the question.

SHRI SANTOKH SINGH I wanted to know the number of projects that have been handed over to the various entrepreneurs for commercialisation as a result of the research work in the National Laboratories.

SHRI M. C. CHAGLA: There are several projects that have been approved and many of them have been taken up by Industry. Well, I have not got the exact figures, but if the hon. friend wants it, I can give him the exact number of projects ' which were undertaken by the 'National Laboratories and which have been taken up by Industry and commercially utilised.

SHRI G. RAMACHANDRAN; There was an admission in what the Minister of Education said, namely, that there is some kind of relationship hetween expenses on research and evaluation of the results *oi* research. "Now, is this not very 'dangerous

admission to make which will create later on far more difficulties?

ShhI M. C. CHAGLA: I do not know that it is a dangerous admission, but I think our country should spend more an^ more money on research. The future of science, of Industrialisation, depends upon research. We are not spending enough money on research. We should spend much more. I fail to understand why the hon. Member thinks that it is a dangerous admission

SHRI G. RAMACHANDRAN: I am afraid the hon. Minister has completely misunderstood my question. I was saying that in answering the question the hon. Minister seemed to admit that he could somehow show that there was an Intimate relationship between expenses on research and the results of research. I said to admit 'this is a dangerous thing.

SHRI M. C. CHAGLA: I do not think so. I said that we are spending more and better results have been produced.
