SHRI Y. B. CHAVAN: I think, Sir, the whole situation arose out of certain incidents on the 'Holi' day, and there was some sort of scuffle between two groups, but the party concerned gave their apologies to some of the defence personnel and they accepted the apology and the whole matter ended there.

SHRI Y. B. CHAVAN; I have no information if anybody is a relation of Sardar Pratap Singh Kairon. I have no information. He may have been there also, but I cannot say.

#### SECOND BANDUNG-TYPE CONFERENCE

\*125. SHRI A. M. TARIQ: Will the PRIME MINISTER be pleased to state:

(a) whether it is a fact that the second Bandung-type Conference is likely to be held at Djakarta shortly;

(b) who were the members of the Indian delegation to the preparatory committee of the Conference; and

(c) whether it is a fact that the Government of the United Arab Republics are not attending the Conference; if so, what are the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DINESH SINGH) ; (a) to (c) A statement is placed on the Table of the House. [See Appendix XLVII, Annexure No. 2].

SHRI A. M. TARIQ; In a paper comprising the Statement it has been

said:

"It was proposed that an invitation be extended to the U. S. S. R. Some delegations supported and others opposed the proposal. . . ."

May I know, Sir, the names of the delegations who supported the invitation to Russia and those who opposed it?

SHRI DINESH SINGH: The proposal was largely supported by Ceylon and some other countries. Sir, It was largely opposed by China and Pakistan.

SHRI A. M. TARIQ: As it is being said that the invitation to Soviet Russia is still under consideration, if Soviet Russia is not invited to this Conference, what will be the attitude of the Indian Government?

SHRI DINESH SINGH: That is a hypothetical question.

SHRI A. M. TARIQ: It is not a hypothetical question; it is a real question. The question is that this invitation . . . .

MR. CHAIRMAN: I have understood it. It is clear but hypothetical.

SHRI A. M. TARIQ: The question arises because the countries were divided, the countries which supported the invitation and the countries which did not, and the hon. Minister was not in a position to say categorically; he said, some countries supported the proposal, and I ask what are the names and the number of the countries which supported the invitation to Soviet Russia.

MR. CHAIRMAN: He said, principally Ceylon supported it.

SHRI A. M. TARIQ: Now it is not being done—it is a question of

vote—and if the majority are against the invitation to Soviet Russia, what will be the attitude of the Indian Government to attend this Conference?

SHRI JAWAHARLAL NEHRU: That question has not arisen now; when it arises we shall decide.

SHRI M. S. GURUPADA SWAMY: I would like to know whether any criterion has been laid down by the preparatory committee to issue the invitations to various countries?

SHRI DINESH SINGH: Well, it is largely a question of geographical criterion, a question of countries in the geographical area of Asia and Africa.

SHRI I. K. GUJRAL: Is it our policy to attend this Conference irrespective of the fact who others attend? I mean to say, invitations are being extended to some other Governments also, and the decision, as stated by the Prime Minister, will be taken later on. Whether the Soviet Union or other countries are invited or not, will it be our policy—I hope it is not—will it be our policy to attend this Conference irrespective of the fact who others attend?

SHRI DINESH SINGH: The dispute is only in relation to Soviet Russia and Malaysia, and as the Prime Minister mentioned, we shall see when the question arises.

Sri N. SRI RAMA REDDY: I would like to know the way the objections were raised against extending invitations to Malaysia and the U. S. S. R. What was the nature of the objections? I would like to know.

SHRI DINESH SINGH: I would request the hon. Member to read the Statement.

SHRI A. B. VAJPAYEE: Apart from Indonesia, may I know, Sir, whether there were any other countries which opposed inviting Malaysia to the Conference?

SHRI DINESH SINGH: I cannot say offhand whether there were other countries that opposed Malaysia; it was left to be decided later.

SHRI C. D. PANDE: The question of inviting Malaysia has been kept in suspense till the issue between Indonesia and Malaysia has been decided. As the three powers the-Philippines, Indonesia and Malaysia are involved in the dispute for which they want to exclude Malaysia, may I know, Sir, whether, if the dispute is not resolved, other powers will be debarred from the Conference?

SHRI DINESH SINGH: We do not want to exclude Malaysia. We propose inviting Malaysia.

SHRI C. D. PANDE: No, no. What I say is there is the conditional postponement till the dispute is resolved.

SHRI DINESH SINGH: We have been wanting them to come.

SHRI C. D. PANDE: Suppose the dispute is not resolved and there are three parties to the dispute equally responsible, *i.e.*, Indonesia, the Philippines and Malaysia; I want to know whether this bar will extend to all the three parties, since it has been mentioned that Malaysia will not be invited till the dispute is ended.

SHRI DINESH SINGH: It is only stated that this matter should be taken up a little later.

SHRI A. M. TARIQ: It has been stated in the provisional agenda that there will be discussions on the struggle against imperialism, colonialism and neo-colonialism. But no-

thing has been said in the agenda about the question of giving basis to foreign countries in the countries which are involved in Afro-Asian region. As this was raised at the Afro-Asian Conference at Algeria and every Afro-Asian country supported it, why was this item not put on the agenda and will India see that it is put on the agenda and raised there?

SHRI DINESH SINGH: This point is covered by "neo-colonialism."

MR. CHAIRMAN: It is covered by "neo-colonialism", he says.

SHRI N. SRI RAMA REDDY: Sir, my question was seeking a certain clarification, because the statement contains only one bald sentence:

"However, because of objection from certain delegations, this issue was" referred for later consideration."

That is the only reason given.

MR. CHAIRMAN: You don't expect the whole report of those debates to be given to the House. It is all published and, as the hon. Minister just now said, you can look into the communique that has been issued.

**श्री गिर राज किशोर कपूर :** क्या माननीय मंत्रीजी बतलायेंगे कि हमारे मुद्दाओं का विरोध किन किन मुल्कों ने किया है ?

**श्री दिनेश सिंह :** किन मुद्दाओं का ?

**श्री गिरराज किशोर कपूर :** जो सम्मेलन में दिये गये थे।

MR. CHAIRMAN: It is a very indefinite question and there is no need to answer it.

SHRI AKBAR AIJ KHAN: Is the question of racial discrimination to be emphasised at this Conference?
