GURUPADA *371 SHRI M. S SWAMY: Will the PRIME MINISTER be pleased to state:

- (a) whether Government's attention has been drawn to a news-item which appeared in the 'Statesman' of February 13, 1964 wherein it has been stated that the building of the Indian Embassy in Rangoon was stoned by one Pancha Charan for having failed to get a passport to visit India;
- (b) if so, whether any enquiry has been made into the delay in issuing the passport; and
- (c) what action has been taken against the officials in this connection?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DINESH SINGH): (a) Yes, Sir. The person who stoned the Indian Embassy building in Rangoon had however applied for an Emergency Certificate to come to India for permanent settlement and not a passport.

- (b) The applicant was informed by the Embassy that it would be necessary to make enquiries in India regarding his claim to Indian origin before an Emergency Certificate could be issued to him. He had approached the Embassy on the 4th February, 1964. The incident occurred on the 11th February, 1964. There was thus no undue delay in considering the request of the applicant.

The matter is expected to be finalised shortly after which orders extending the modified scale to Sten> graphers and others in Armed Forces Headquarters (including Service Organisations) will be issued.
