However, based on the recommendations of the Committee under the Chairmanship of Joint Secretary (Pharmaceuticals) and the Task Force under the Chairmanship of Dr. Pronab Sen, Principal Advisor, Planning Commission as well as feedback received from other stakeholders the Government have formulated a Draft National Pharmaceutical Policy, 2006 (Part-A— excluding pricing) which has been circulated to various departments/ stakeholders seeking their comments. Based on the comments received the Government is likely to finalize the new Policy shortly.
