- (a) the details of various schemes and facilities being provided to the farmers who are affected due to floods and droughts;
- (b) the district-wise/State-wise amount provided by Government during the last three years till date to protect the farmers from these serious crises; and
- (c) whether Government have provided any special economic package in this regard during 2005-06?
- THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI KANTILAL BHURIA): (a) to (c) For floods, droughts and other natural calamities, following are the main facilities as laid down by the Award of Twelfth Finance Commission;
 - (i) Assistance from Calamity Relief Fund (CRF) to meet expenditure on ordinary calamities on a regular basis.
 - (ii) Assistance from the National Calamity Contingency Fund (NCCF), administered by the Ministry of Home Affairs, to meet the requirements in severe calamities as a special case.
 - Farmers are the main beneficiaries of such assistance. Information relating to assistance given from the NCCF for floods and droughts during last three years are indicated at statement (See below). No district-wise allocations are made for the purpose.
 - (iii) Standard guidelines have been issued by the Reserve Bank of India/NABARD to the banks for providing relief to the farmers in areas affected by natural calamities. These include conversion/ rescheduling of loans, grant of fresh crop loans, conversion of principal as well as interest due on existing loans into term loans, not to compound interest on loans converted/rescheduled and not to charge penal interest on current dyes.
