(a) whether he is empowered to employ staff artistes in the All India Radio on contract basis upto a monthly salary of Rs. 1500; and

(क) और (ख) स्टाफ आर्टिस्टों को मासिक फीस फ्रंटकर खर्च में से दी जाती है, जिस को खर्च करने का विभिन्न मंत्रालयों को पूर्ण अधिकार प्राप्त है ?

इसलिए सूचना और प्रसारण मंत्रालय को स्टाफ आर्टिस्टों को किसी भी मासिक फीस पर रखने के अधिकार तभी से प्राप्त हैं जब से आकाशवाणी की स्थापना हुई और स्टाफ आर्टिस्टों के पद चालू हुए ।

†[THE MINISTER OF PARLIAMENTARY AFFAIRS (SHRI SATYA NARAYAN SINHA); (a) and (b) Staff artistes are paid monthly "fee", an item of contingent expenditure, for incurring of which various Ministries have got full powers.

Information and Broadcasting Ministry has, therefore, been empowered to engage staff artistes on any monthly fee ever since the institution of staff artistes came into vogue with the establishment of the A.I.R.]
