THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR AND EMPLOYMENT AND FOR PLANNING (SHRI C. R. PATTABHI RAMAN): (a) and (b) Attention is invited to replies given to Starred Question Nos. 302 and 276 answered respectively on August 29, 1963 and February 26, 1964. The Committee on Transport Policy and Coordination has been reconstituted and it is hoped that the final report of the Committee will be available in the course of the next 3 months or so.

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH (DR. D. S. RAJU): A statement containing the names of the Honorary Family Planning Education Leaders appointed up to 31st January, 1964 is enclosed. [See Appendix XLVI, Annexure No. 41.] A District Family Planning Education Leader is required to work in the District allotted to him/her whereas a Regional Leader works in 4 to 5 Districts. The Institutional Leaders are required to intensify the Family Planning Programme in the branches of their organisations.

THE MINISTER OF INDUSTRY (SHRI N. KANUNGO) : (a) and (b) The Madhya Pradesh Government have been requested to let us have a list of such applications as have been recommended by their Department of Industries, with particulars of items and quantities recommended. On receipt of this list, efforts will be made to collect the information as to the actual quantities licensed.]

CONVERSION OF TEMPORARY POSTS INTO PERMANENT ONES

371. SHRI LILA DHAR BAROOAH: Will the Minister of FINANCE be pleased to state;

(a) whether it is a fact that the decision taken by the Ministry of Finance to convert 80 per cent, of temporary posts into permanent ones, has not been fully implemented by all the Ministries so far;

(b) if so, what are the reasons therefor; and

(c) whether any instructions have been issued recently by the Ministry of Finance in this regard?

THE MINISTER OF FINANCE (SHRI T. T. KBISHNAMACHARI) : (a) Orders were issued in March, 1960, that 80% of the temporary posts in permanent Departments, other than the Posts and Telegraphs Department and Government Workshops and Industrial Establishments, which have been in existence for a continuous period of not less than 3 years and which are required for work of a permanent nature, may be converted into permanent ones. The progress made by the various Ministries/Departments in this regard was reviewed in October, 1961 and it appeared that, by and large, adequate action had been taken or was being taken in the matter.

(b) Does not arise.

(c) No, Sir, but it is proposed to* make a further review in the near future.
