388. SHRI B. N. BHARGAVA: Will the Minister of FINANCE be pleased to state whether it is a fact that the Life Insurance, Corporation has decided to construct houses for people in Delhi; if so, to what class of people and on what conditions the houses will be given?]

REGULARISATION OF UN-AUTHORISED STRUCTURES

389. SHRI DHANANJOY MOHANTY: Will the Minister of WORKS, HOUSING AND REHABILITATION be pleased to state:

(a) whether it is a fact that Government constituted a Committee under Shri Anil K. Chanda to examine which of the un-authorised structures could be regularized in accordance with assurances given in Government Resolution No. 26/15/60-Acc. dated 11th July, 1960; and

(b) if so, what are the particulars of the cases which were recommended by this Committee for regularization?

THE MINISTER OF WORKS, HOUSING AND REHABILITATION (SHRI MEHR CHAND KHANNA) ; (a) and (b) A Committee under the Chairmanship of Shri Anil K. Chanda was set up under the Resolution dated the 11th July, 1960, to consider the question of regularisation of un-authorised structures put up by displaced persons on Government land prior to the 15th August 1950. The Committee inspected various sites and in most cases its recommendation was that the existing un-authorised structures should be demolished, and that provision should be made elsewhere for unauthorised occupantj.
