tion of the Damodar Valley Corporation is under consideration in consultation with the other participating Governments, as the principal object in setting up the Corporation, namely flood control, has been achieved to the extent possible.

SHRI M. S. GURUPADA SWAMY: May I know whether one of the reasons for changing the set-up is the enormous delay and inefficiency that have cropped up in the working of this project and the incompetence exhibited by this Corporation all along? If that is so, what action has been taken against those officials who were responsible for such delay and incompetence?

DR. K. L. RAO: The main reason is, as I have already said, because the object for which this Corporation was set up has been achieved. Besides this, the other reasons would be that the irrigation potential of the project had been fully exploited and the extension of the power generation is being objected to by the West Bengal Government. The hon. Member's reasons are not the ones on which the reorganisation has been decided upon.

SHRI N. C. KASLIWAL: May I know exactly what the Minister means by reorganisation of this Corporation and whether that means that the organisation as a whole is now teing handed over to the West Bengal Government?

D\*. K. L. RAO: I submit tha" reorganisation is under consideration but broadly I can state that the reorganisation will be made on the funct ona! basis, namely, the irrigation aspects would be transferred to the West Bengal Government and it has already been transferred, and power wi'l be taken over by the Central Government. The other subsidiary subjects like the fisheries, soil conservation etc. will be dealt with by the respective State Governments.
