- (b) (i) Teachers of Classical languages.—B.A. (with the classical language concerned as a subject) or its equivalent Oriental degree in the classical language concerned plus a degree or diploma in Education or 5 years' experience of teaching the classical language concerned in college or secondary classes.
- (ii) Teachers of modern Indian languages.—A university degree with Shastri or its equivalent or a corres-p'onding examination in the modern Indian language concerned or a university degree with the modern Indian language concerned as an optional subject with a degree or diploma in Education or 5 years teaching: experience.
