(e) Sheets thinner than 20 gauge are being allowed to be imported whenever possible under barter deals.

LOSSES IN GAUHATT REFINERY

- 406. SHRI SITARAM JAIPURIA: Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:
- (a) whether it is a fact that the Nunmati refinery at Gauhati is working at a heavy loss;
- (b) if so, the reasons for the failure of the project; and
- (c) what remedial action Government have taken to improve the situation?

THE MINISTER OF PETROLEUM AND CHEMICALS (SHRI HUMAYUN KABIR): (a) and (b) No, Sir, but some loss is due to prolonged troubles in the Kerosene Refining Unit and limited quantity of the off-take of products. Stoppage of water supply to the pumping station between 26th October and 15th November, 1963 was also a contributory cause.

(c) Measures have been taken to improve the working of the refinery by completion of major overhaul and modifications in the Kerosene Refining Unit, increasing the number of rail tank-wagons for the product off-take and improving water supply arrangements.

NUNMATI REFINERY PRODUCTS SOLD TO FOREIGN OIL COMPANIES

. / SHRI BHUPESH GUPTA: \ DR. A. SUBBA RAO:

Will the Minister of Petroleum and Chemicals be pleased to state:

- (a) whether the agreements under which the Nunmati refinery products are sold by the Indian Oil Company to the foreign oil companies in the country have been reviewed;
- (b) if so, whether the agreements have revealed a number of loopholes which have resulted in heavy loss to the Indian Oil Company;

- (c) whether these loopholes include (i) lower basic cost structure, and (ii) incorporate marine freight incorporated into the price structure; and
 - (d) if so, the exact under-estima-tions?

THE MINISTER OF PETROLEUM AND CHEMICALS (SHRI HUMAYUN KABIR): (a) and (b) The disposal of Nunmati Refinery products by the Indian Oil Company and by the foreign oil companies was arranged under an agreement with those companies, for exchange for some products and for out-right sale of others. The terms were settled to the best mutual interest of the refinery and the oil companies, taking into account the price formula and other relevant considerations. In the circumstances in which the arrangements were made, it cannot be said there were loopholes which would cause avoidable loss. New product exchange arrangements between the Indian Oil Company and the private oil companies are being negotiated in the context of products from Barauni Refinery becoming available in the near future.

- (c) No, Sir, the elements of basic cost and marine freight are calculated on the basis of the principles laid down by the Oil Prices Enquiry Committee.
 - (d) Does not arise.
