\*543. SHRI RAM SAHAI: Will the Minister of PETROLEUM AND CHEMICALS be pleased to state whether Government propose to reduce the price of penicillin; if so, to what extent and when this proposal will be implemented?]

### ASSESSMENT OF THE SHARE VALUE OF JESSOP & Co., CALCUTTA

\*545. SHRI SHER KHAN: Will the Minister of STEEL, MINES AND FUEL be pleased to state:

(a) whether Government have assessed through a body of experts the value of the shares of M/s. Jessop and Co., Limited, Calcutta; and

(b) if not, whether Government have any proposal to do it now?

THE MINISTER OF STEEL, MINES AND HEAVY ENGINEERING (SHRI C. SUBRAMANIAM) : (a) No, Sir.

(b) Some proposals have been under the consideration of Government, but no final decision has been taken so far.

### CONSTRUCTION IN GREEN PARK COLONY

\*546. SHRI P. N. KATHJU: Will the Minister of HOME AFFAIRS be pleased to state whether it is a fact that during the years 1962 and 1963, the Delhi Municipal Corporation declined to accept applications seeking permission for the construction of buildings in the Green Park colony in New Delhi and its Extension and, if so, what is the reason for such action?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (Smt L. N. MISHRA) : A statement based on the information furnished by the Delhi Municipal Corporation is placed on the Table of the House.

### STATEMENT

The building activity in the combined shopping centre of Green Park and Green Park Extension was suspended in December, 1962. This was done due to the reason that the coloniser had shown others' land as his own property in the layout plan of the colony. In this connection, two complaints were received and the coloniser was asked to explain. Later on the coloniser settled the dispute with the complainant. In the meantime on the complaints of the residents regarding insufficient water supply, the question of water supply and other services in the colony was looked into. The coloniser had installed one tube-well which was not enough to supply water to the whole of the colony. The coloniser was asked to install another tube-well but he failed to do so. To ensure adequate water supply to whole of the colony, the

building activity in the entire colony was suspended on 15th May, 1963.

The coloniser then installed tube-well and made good other deficiency in the services. The Corporation having been satisfied with the development work permitted the building activity on 19th November, 1963 in the entire colony except three small pockets where there was some dispute on ownership.

THE MINISTER OF STEEL, MINES AND HEAVY ENGINEERING (SHRI C. SUBRAMANIAM): (a) M/s. Pearl Scooters, Ludhiana has started production of Scooters at Ludhiana.

Ob) The firm is producing Scooters in technical collaboration with M/s. Yamaha of Japan.

(c) A first lot of their production has already been marketed and the second lot is expected to be marketed soon.
