Evening Shift (Second shift) —

From 1st April to 30th September—12-30 P.M. to 5-00 P.M.

From 1st October to 31st March of the year succeeding.— 1-00 P.M. to 6-00 P.M.

(b) Excepting Chowkidars, the same working hours as prescribed for other staffworking in the schools. Chowkidars remain on duty during the period when the schools are closed.
