THE DEPUTY MINISTER IN THE MINISTRY OF LAW (SHRI BIBUDHEK-DRA MISRA) : The State Governments of Andhra Pradesh, Orissa, Punjab and Uttar Pradesh and the Administrations of Himachal Pradesh and Andaman & Nicobar Islands have replied so far to the Questionnaire on Capital Punishment issued by the Law Commission. They are generally in favour of the retention of Capital Punishment.
