(b) whether Government are making any changes in the rules or are taking any steps to lessen the evil of blackmarketing in newsprint?]

संसद्-कार्य मंत्री (श्री सत्य नारायण सिंह) : (क) समाचार-पत्रों द्वारा अखबारी कागज चोर बाज़ार से खरीदने की पिछले दो साल के दौरान कोई शिकायत नहीं मिली है। कुछ समाचार-पत्रों और पत्रिकाओं के विरुद्ध अखबारी कागज की बिक्री की शिकायतें समय समय पर प्राप्त होती हैं। क्योंकि शिकायत होने से ही आपत्तिजनक सोदे का आरोप मिद्ध नहीं होता, इसलिये ऐसे समाचार-पत्रों के नाम देना वांछनीय नहीं।

(ख) समाचार-पत्रों के सर्कुलेशन के दावों की जांच करते समय, प्राप्त शिकायतों के बारे में पूरी छानबीन की जाती है और संदिग्ध पत्रों को अखबारी कागज का कोटा पूरी जांच-पड़ताल के बाद दिया जाता है और सर्कुलेशन की जांच के आधार पर वास्तविक आवश्यकता के अनुसार अखबारी कागज के कोटे में संशोधन कर दिया जाता है।

सर्कुलेशन के आधार पर मुख्यतः समाचार-पत्रों को अखबारी कागज का कोटा दिया जाता है, इसलिए इन की जांच में अधिक कड़ाई की गई है। अखबारी कागज की चोरबाज़ारी को रोकने के लिए अन्य प्रशासनिक उपाय भी किए गए हैं।

†[THE MINISTER OF PARLIAMENTARY AFFAIRS (SHRI SATYA NARAYAN SINHA): (a) No complaints regarding purchase of newsprint by newspapers in blackmarket have been received during the last two years. Complaints regarding alleged sale of

newsprint by some newspapers and periodicals are received from time to time. As complaints by themselves do not establish any objectionable transaction, it is not considered desirable to give the names of such newspapers.

(b) While verifying the circulation claims of newspapers, prompt enquiries are made into complaints received and allocation of newsprint to suspected papers is made after strict scrutiny and newsprint quota is re-adjusted to meet actual requirements, assessed on the basis of verified circulation.

The verification of circulation figures on which newsprint quota newspapers is mainly based has been intensified. Other administrative measures have also been taken with a view to lessening the evil of blackmarketing in newsprint.]

(a) the rates at which the plots of land were purchased from the Karachi Municipal Corporation in May 1952;

(b) the efforts that were made to sell these plots and when the efforts were made;

(c) the present market rate of the plots of land in that area; and

(d) the annual expenses which are being incurred on the maintenance of the plots at present?]
