- (b) if so, what is the number of such shops;
- (c) whether it is a fact that these confectioners are not given any sugar quota for their requirements and they have to purchase sugar in blackmar-ket; and
- (d) if so, the reasons for the same and what steps are being taken in this connection?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD AND AGRICULTURE (SHRI A. M. THOMAS): (a) and (b) Some confectioners from outside Delhi are reported to have set up their establishments in private houses in Delhi but their number Is not known. There were some exports of sweetmeats but the same have been banned with effect from 19-11-63.
