Rationalisation of project allocation among states

2534. SHRI DHARAM PAL SABHARWAL: SHRIMATI PREMA CARIAPPA:

Will the Minister of RAILWAYS be pleased to state:

- (a) whether there is any proposal with Government to rationalize project allocation among various States particularly Punjab State;
 - (b) if so, the details thereof; and
 - (c) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI NARANBHAI RATHWA): (a) to.(c) No, Sir. Since 2002-03, available funds to various projects are being allocated based on State-wise formula in which weightage of 15% each is given to area and population and balance 70% a throwforward of projects in the State. From 2006-07, doubling and Railway Electrification works have been kept out of the purview of this formula.

Accidents due to over utilisation of tracks

- 2535. DR. K. MALAISAMY. Will the Minister of RAILWAYS be pleased to state:
- (a) whether the over utilization of Railway tracks are instrumental for Railway accidents;
- (b) whether it is a fact that rejected wagon/coaches are reused more and more in the jurisdiction of Southern Railway;
- (c) whether it is also a fact that more accidents happen in Southern Railway; and
- (d) whether the causes have been analysed and corrective measures have been taken?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI NARANBHAI RATHWA): (a) to (c) No, Sir.'

(d) Yes, Sir. Each and every train accident is inquired into" either departmentally or by Commissioner of Railway Safety depending upon seriousness of the accident. The staff held responsible according to the

findings of the Inquiry Committee are taken up under Discipline and Appeal Rules and the accepted recommendations implemented.

Budget provision for new railway lines in Maharashtra

- 2536. SHRI PRAMOD MAHAJAN. Will the Minister of RAILWAYS be pleased to state:
- (a) the comparative figures of budget provision *vis-a-vis* amount spent on new railway lines, widening and doubling of existing rail lines in the State of Maharashtra during the years 2003-04, 2004-05 and 2005-06;
- (b) the steps taken by his Ministry to make adequate budgetary provision on these rail lines during the financial year 2006-07; and
- (c) what steps have been taken to utilize full provision during the coming financial year?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI NARANBHAI RATHWA): (a) The total outlay provided and expenditure incurred for New Line, Gauge conversion and Doubling projects in Maharashtra during 2003-04 and 2004-05 has been Rs. 541 crore and 623.72 crore, respectively. Outlay provided during 2005-06 is Rs. 256.83 crore. The actual expenditure would be known after finalization of yearly accounts.

- (b) Rs. 340.44 crore have been proposed during 2006-07 for various projects under the three plan heads falling fully/partly in Maharashtra.
- (c) Progress of projects has been expedited to ensure utilization of funds

Luggage trolleys at major stations
