#### REPORT OF N.C.D.C. FOR 1962-63

**THE MINISTER OF STEEL, MINES AND HEAVY ENGINEERING (SHRI C. SUBRAMANIAM):** (a) and (b) Rule 52 (2) of the Defence of India Rules, 1962, read with Rule 52(1) prohibits a person from publishing or causing or allowing to be published the accounts of a colliery or mining undertaking or any report or other documents relating to operation of such undertaking which discloses any information contained in such accounts or any statistical and other information relating to the progress of the undertaking. It is, however, proposed to amend this rule and the question of publication of the report will be considered in the light of the amended rule.
