**POWER SITUATION AT THE END OF THE THIRD PLAN**

\*424. SHRI N. C. KASLIWAL: Will the Muvster of IRRIGATION AND POWER be pleased to state:

(a) what is likely to be the total demand for power at the end of the Third Five Year Plan; and

(b) whether there will be any shortage in power supply?

THE MINISTER OF IRRIGATION AND POWER (DR. K. L. RAO): (a) About 8.3 million K.W.

(b) Excepting the States of An-dhra Pradesh, Gujarat, Punjab, Rajas-than and Uttar Pradesh there will be no shortage in power supply at the end of Third Plan.
