

**INTERNATIONAL COAL CONFERENCE AT  
TOKYO (JAPAN)**

451. DR. A. SUBBA RAO: Will the Minister of STEEL, MINES AND HEAVY ENGINEERING be pleased to state:

(a) the expenditure incurred on the delegation which participated in the International Coal Conference held at Tokyo, Japan during October, 1963; and

(b) how many in the delegation were Mining Engineers?

THE MINISTER OF STEEL, MINES AND HEAVY ENGINEERING (SHRI C. SUBRAMANIAM) : (a) An expenditure of Rs. 19,522.60 nP. was incurred on the three delegates from Government, namely a representative of the Ministry of Mines & Fuel, the Chair-Kian of the National Coal Development Corporation, and the General Manager of the Singareni Collieries Co Ltd., Andhra Pradesh. Besides *ihet.* delegates, four representatives of the private sector also went. They met their own expenses, and so the expenditure incurred by these non-officials is not known.

(b) One of them is a Mining Engineer.

**CEMENT PRODUCTION**

452. DR. A. SUBBA RAO: Will the Minister of STEEL, MINES AND HEAVY ENGINEERING be pleased to state:

(a) whether the target for cement production during the Third Five Year Plan is likely to be achieved; and

(b) if not, whether the target is likely to be slashed down?

THE DEPUTY MINISTER IN THE MINISTRY OF STEEL, MINES AND HEAVY ENGINEERING (SHRI P. C. SETHI): (a) and (b) On the basis of the progress made so far in the implementation of the pending schemes, the annual installed capacity of the cement industry is expected to reach the level of 14.4 million tonnes by the end of the Third Five Year

Plan against the target of 15.2 million tonnes. Efforts are being made to speed up the progress of several pending schemes so as to reach the target.
