CLOSURE OF MICA MINES IN BIHAR

588 Shri DHANANJOY MOHAN-TY: Will the Minister of STEEL, MINES AND HEAVY ENGINEERING be pleased to

- (a) whether Government's attention has been drawn to the closure of a number of mica mines in Bihar;
- (b) if so, what are the reasons for such closure; and
- (c) what is the number of workers affected thereby and what action Government propose to take to provide them with alternative employment?

THE DEPUTY MINISTER IN THE MINISTRY OF STEEL, MINES AND HEAVY ENGINEERING (SHRI P. C. SETHI): (a) According to the notices received by the Director, Indian Bureau of Mines, under the Mineral Conservation and Development Rules, 1958, a total number of 42 mica mines are reported to have been temporarily closed and 5 mines permanently closed against 39 mines re-opened and 19 new mines opened during the period January to November, 1963.

- (b) The main reasons from time to time, for the closure are reported to be (i) slackening of demand for particular varieties in the international market; (ii) rainy season; and (iii) inadequate supply of explosives.
- (c) The total number of workers affected by the closure of mica mines is reported to be about 750, while the new mines opened and mines reopened are reported to have provided employment to more than 500 workers. Workers rendered unemployed due to closure mines are given retrenchment compensation, where entitled.
