THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI SHAM NATH) (a) A common fleet of 10 vehicles is maintained by the News Services Division for bringing the staff artists and essential staff of News Services Division and External Services Division from residence  $t_0$  office and back during odd hours, and also for their second and subsequent visits to office, if any, during normal office hours.

(b) The average annual expenditure on the common pool of vehicles for News Services Division and External Services Division is Rs. 1,45.200. No separate figures of expenditure for the News Services Division alone are available.

SHRIMATI NANDINI SATPATHY: May I know, Sir, whether there are Government quarters near the Radio Station for these men and, if so, who are the occupants?

SHRI SHAM NATH: There are no Government quarters near the place of duty. And generally to staff artists and members of essential staff who live at a distance of three and half miles or more, transport facilities are provided.

SHRI A. M. TARIQ: May I know if the hon. Minister has got some complaints from persons, who are working in the News Services Division and who are actually entitled to use this transport, that they do not get transport in time and, also, some persons who are not entitled are getting transport and, if so, what action has been taken?

SHRI SHAM NATH: I am not aware of any such complaint.

SHRI A. M. TARIQ: What is the reply, Sir?

MR. CHAIRMAN: He is not aware of any such complaint.

We have not sent any communication to the workers' representative, but we have, •of course, been in correspondence with the Ceylon Government on the subject and I have suggested that the Prime Minister of Ceylon might visit Delhi to discuss these matters further.

SHRI CHANDRA SHEKHAR: The President of the Ceylon Workers' Congress, after his return from Delhi, issued a statement there at Colombo saying that the attitude of the Indian Government was very helpful in the matter. May I know from the Government of .India what is the attitude of the Ceylon Government, whether they have received any reply to the communication of the Prime Minister or not? The Prime Minister has said that he has been in correspondence with them. Has any reply been received from the Prime Minister of Ceylon?

MR. CHAIRMAN: What is the response ha asks.

SHRI JAWAHARLAL NEHRU: As I have said, we have been in correspondence with them. I sent a letter to the Prime Minister of Ceylon some time back, two or three months ago, to which I got a detailed reply. And as there was considerable difference •of opinion, I suggested that she might take the trouble to come here as our guest and that we could discuss it further.

SHRI A. D. MANI: As there are conflicting estimates about the number of Stateless persons in Ceylon, would

## EQUITABLE REPRESENTATION ON THE SECURITY COUNCIL AND ECONOMIC AND SOCIAL COUNCIL

(a) whether there has been a move on the part of several Afro-Asian countries to get the question of equitable representation on the Security Council and the Economic and Social Council included in the agenda of the current session of the United Nations General Assembly; and

(b) if so, what is Government's reaction to this move?

THE MINISTER OF STATE IN THB MINISTRY OP EXTERNAL AFFAIRS (Shrimati Lakshmi N. Menon): (a) Yes, Sir.

(b) The Government of India are in favour of increased representation of Asian and African countries on these bodies in view of the large increase in the membership of these countries in the United Nations. The current session of the General Assembly has inscribed a relevant item on the agenda at the request of a large number of members including .India.

SHRI N. C. KASLIWAL: May I know whether the Government have received any indication from the Latin American bloc, owing to their attitude to this question, because if an equitable representation on the Security Council is to come about it is likely that they will lose one seat?

SHRIMATI LAKSHMI N. MENON: There are two methods by which this can be done. One is by redistribution of the existing seats and the other *is*
