REDDY:

Will the Minister of DEFENCE be pleased to state:

(a) whether the joint air exercises have begun; if so, from which date; and

(b) the number of Indian Air Force personnel and the number of trainers who are taking part in it?

प्रतिरक्षा मंत्रि (श्री वाई. बी. चव्हाण) :

(क) जी हा, ९ नवम्बर, १९६३ को रायल एयर फोर्स के साथ, और १४ नवम्बर, १९६३ को यू. एस. एयर फोर्स के साथ अभ्यास १९ नवम्बर को समाप्त हुए ।

(ख) सब मिला कर ४,००० भारतीय वायु सेना के सेवि वर्ग और लगभग ७५० रायल एयर फोर्स, यूनाइटेड स्टेट्स एयर फोर्स तथा रायल ऑस्ट्रेलियन एयर फोर्स के सेवि वर्ग ने इस में भाग लिया ।

†[THE MINISTER OF DEFENCE (SHRI Y. B. CHAVAN): (a) Yes, Sir; on 9th November 1963 with the Royal Air Force and on 14th November 1963 with the U. S. Air Force. The exercises concluded on the 19th November.

(b) Altogether about 4000 Indian Air Force personnel, and about 750 Royal Air Force, United States Air Force, Royal Australian Air Force personnel participated.]

PAKISTAN'S PROPAGANDA ON INDIAN SUPPLY OF JUTE TO EUROPEAN COUNTRIES

*177. SHRI N. SRI RAMA REDDY: Will the PRIME MINISTER be pleased to state whether Pakistan's propaganda to the effect that India was

supplying jute to European countries for onward transmission to South Africa has come to the notice of the Government of India?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DINESH SINGH): Yes, Sir. This propaganda is entirely baseless. We have no trade with Union of South Africa, direct or indirect. In fact, our Trade Agreements with these countries provide against the re-exporting of our goods to other destinations. On the other hand Pakistan has substantial trade relations with South Africa.

DEMARICATION OF BOUNDARY BETWEEN INDIA AND WEST PAKISTAN

*178. SHRI J. H. JOSHI: Will the PRIME MINISTER be pleased to state:

(a) whether the boundary between India and West Pakistan is being demarcated;

(b) if so, the length of the boundary that has remained undemarcated so far; and

(c) what is the cost of the demarcation per hundred miles?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DINESH SINGH): (a) Yes, Sir. Demarcation on the ground has been completed in respect of the Indo-West Pakistan boundary on the Punjab and Rajasthan Sectors, but excluding the Indo-West Pakistan boundary on the Jammu and Kashmir sector.

(b) Demarcation on the ground in respect of Gujrat-West Pakistan Sector has not started yet.

(c) An approximate statement of expenditure is placed on the Table of the House.

The Survey of India have claimed an expenditure of Rs. 15,33,738 as having been incurred by them in respect of demarcation of this boundary. But as they are also a Central Government Agency, the Ministry of External Affairs have not reimbursed them.

CALCUTTA DOCK LABOUR BOARD

*179. SHRI S. C. DEB: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

(a) whether the recommendations of the Mehta Committee have been fully implemented in so far as the working of the Calcutta Dock Labour Board is concerned; and

(b) whether the Ministry has recently received a representation for setting up an enquiry into the working of the said Labour Board under the amended section 6A of the Dock Workers (Regulation of Employment) Act, 1948?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR AND EM-

PLOYMENT (SHRI RATANLAL KISHORILAL MALVIYA): (a) Out of 56 recommendations, 35 have been implemented, 11 are in the course of implementation and the rest have been brought to notice of the authorities concerned.

(b) Yes. The matter has been considered and Government is satisfied that there is no need to order any such enquiry.
