THE MINISTER OF STEEL, MINES AND HEAVY ENGINEERING (SHRI C. The steps which SUBRAMANIAM): Government propose to take for the realisation of the interest are still The question under consideration. was complicated by the fact that a Committee set up by the Ministry of Iron and Steel had recommended certain measures of de-control which, if accepted, would have resulted in a different situation under the agreements with the steel companies. Government, however, hope to give an early decision on the recommendations of the Committee and will take the further steps necessary for the realisation of interest from the companies thereafter.

PASSPORT RACKET IN PUNJAB
