The Japanese Company supplied good quality dials immediately at their cost for effecting replacement of dials in the watches already sold. All the customers had been informed by the Hindustan Machine Tools Ltd., that replacement of discoloured dials would made free of cost including postage and insurance charges. It is "understood that the defect in the dial was due £0 certain changes by the Japanese Company in the manufacturing process. The Japanese Company have agreed t₀ supply the Hindustan Machine Tools Ltd., free of cost, defect-free dials as -Well as any compensation Hindustan Machine Tools Ltd. would demand T₀ be independent of the imported dials, the Hindustan Machine Tools Ltd. have under taken the manufacture of quality dials. all the watches From November 1963 Hindustan Machine Tools manufactured in Limited are provided with dials manufactured by them.

INSTITUTE OF RURAL HIGHER EDUCATION, SRINIKETAN

- (a) whether it is a fact that the Institute of Rural Higher Education, Sriniketan which was started in 1956, has since been closed; and
 - (b) if so, the reasons therefor?

The MINISTER of EDUCATION (SHRI M. C. CHAGLA): (a) and (b). The Institute $_0$ f Rural Higher Education, Sriniketan, has since been closed on account of certain internal difficulties arising out of the conduct of some of the students. It has subsequently been dissolved with effect from the 31st August, 1963. A new academic department under the name "Palli Siksha Sadana" has been started at Visva-Bharati with effect from 1st September, 1963. The "Sadana" is for the present having a three-year degree course in Social Sciences and a three-year diploma course in Agricultural Science.

LIBRARY OF THE INDIAN INSTITUTE OF TECHNOLOGY, DELHI

- 236. SHRI R. S. KHANDEKAR: Will the Minister of EDUCATION be pleased to state:
- (a) whether it is a fact that there is n_0 well-equipped library attached to th_e Indian Institute of Technology, Delhi;
- (b). whether there Is any proposal to equip the library according to the standard of the post-graduate classes; and
- (c) if so, when the proposal will materialise?

THE MINISTER OF EDUCATION (SHRI M. C. CHAGLA): (a) No, Sir. The library of the Indian Institute of

Technology, Delhi, has about 20,000 books and periodicals which adequately meet the present needs of both the under-graduate and the postgraduate classes.

(b) and (c) The Development Plan of the Institute makes provision for expansion of the library to meet the future needs for various courses. Adequate sums of money will be provided in the annual budgets of the Institute for this purpose.

CHAGLA): Universities are selected for business and industrial management courses on the recommendations of the An India Council for Technical Education and its Board of Management Studies. The Criteria generally laid down by the Council are the need for such courses in the areas concerned and availability of sufficient instructional facilities in associated subjects like Accountancy, Law, Psychology, Economics etc.

RECOMMENDATIONS OF WORKING GROUP ON COAL PRODUCTION AND TRANSPORT
