MEETING OF REPRESENTATIVES OF HEC, HINDUSTAN STEEL, ETC.

228. SHRI M. P. BHARGAVA: Will the Minister of STEEL, MINES AND HEAVY ENGINEERING be pleased to state:

(a) what decisions have been taken in the meeting of the representatives of the Heavy Engineering Corporation, Heavy Electricals, Hindustan Steel and Dastur and Company for working out an integrated programme for the supply of machinery and equipment to the proposed steel plants at Bokaro and other places;

(b) whether any conference of representatives of major fabricating units in the country was also convened; and

(c) if the reply to part (b) above be in the affirmative, what decisions were taken by them?

THE MINISTER OF STEEL, MINES AND HEAVY ENGINEERING SHRI C. SUBRAMANIAM): (a) The decisions taken were:

1. A conference of Heavy Engineering Corporation and all potential manufacturers to be convened shortly.

2. A committee on Design Organisation to recommend *inter alia* on the following items:

(a) Organisational set up or undertaking plant engineering coordination and detailed designs for manufacture of Iron and Steel Plant including ancillaries.

(b) Design organisation in HEC for undertaking manufacture of one or two blast furnaces,
