**^CONSTRUCTION OF SPURS ON PAKISTAN
SIDE OF FENI RIVER**

284. SHRI T. M. DASGUPTA: Will the
PRIME MINISTER be pleased to state:

(a) whether it is a fact that East Pakistan
authorities recently constructed some new
spurs on the Pakistan side of the Feni river to
divert erosion of bank to the Tripura side; and

(b) if so, what is their number and what
steps Tripura Administration has taken to stop
erosion of the bank on the Sabroom side of
the Feni river and what is the reply of the East
Pakistan Government to the protest, if any,
lodged by Tripura Administration in this
behalf?

THE PRIME MINISTER AND MINISTER
OF EXTERNAL AFFAIRS (SHRI
JAWAHARLAL NEHRU): (a) Yes, Sir.

(b) According to reports received from
Tripura, eleven to fourteen spurs have been
constructed by Pakistan on the Feni river at
Sabroom and another twentyfive at
Baishanabpur.

Protests have been lodged with the East
Pakistan authorities at both the District and
the State Government levels, against the
construction of spurs. Since Pakistan
continued with their construction, India had to
put up

a few spurs on their side as an anti-erosion
measure and for the protection of life and
property on Indian territory.

The East Pakistan Government have been
requested to issue instructions to the Deputy
Commissioner, Chittagong Hill Tracts for a
meeting with the District Magistrate, Tripura,
where the matter could be discussed and, if
possible, settled. A favourable reply from
Pakistan is awaited.

**STATEMENT RE STARRED QUES-
TION NO. 154 ANSWERED EARLIER IN
THE DAY**

**PUBLICATION OF MAP OF INDIA WITHOUT
KASHMIR IN "THE ROTARIAN"**

SHRI SITARAM JAIPURIA (Uttar
Pradesh): Madam, while you were on Starred
Question No. 154 regarding the magazine 'The
Rotarian', I wanted to make a certain
clarification and I wanted to ask a
supplementary. The editor of the magazine
has already apologised, and as I happen to be
one of the past Governors of the Rotary
International, I know that it is never the policy
of the Rotary International to involve itself in
partisan feelings at all. Just for the sake of
completion of the records and for information,
I would like this to be passed as one of the
parts of the records. It says—

"We regret having hurt the feelings of
Rotarians in India, and we promise to
exercise care in such matters in the future.
We agree that Rotary International should
be kept above involvement in partisan
feelings or propaganda."

This letter, Madam, is dated . . .

SHRI BHUPESH GUPTA (West I
Bengal): How does it come?

SHRI SITARAM JAIPURIA; . . . , 25th
February.

THE DEPUTY CHAIRMAN: The Short Notice Question is over. There are no more questions. Mr. Jaipuria has asked for permission to explain and he is doing.

SHRI SITARAM JAIPURIA: I- am only giving an explanation.

THE DEPUTY CHAIRMAN: The issue of 'The Rotarian'

SHRI BHUPESH GUPTA: On a point of order, what is Mr. Jaipuria explaining? We had a question

THE DEPUTY CHAIRMAN: He is explaining about the question . . . i .

SHRI BHUPESH GUPTA: That is nothing. We had a question relating to the Ministry. The question was whether attention has been drawn to such and such a thing. Mr. Jaipuria may or may not be a member of the Rotary Club. But why should he make that statement here? (*Interruptions*) .

THE DEPUTY CHAIRMAN: Mr. Jaipuria wants to make a statement. Let him make it.

SHRI BHUPESH GUPTA: I have every day half a dozen statements to mak?.

THE DEPUTY CHAIRMAN: You do more than half a dozen times. (*Interruptions*)

DIWAN CHAMAN LALL (Punjab): May I draw your attention, Madam, to Rule 203 of the Rules of Procedure according to which, with your permission, any hon. Member can make a personal explanation?

THE DEPUTY CHAIRMAN: That is what he is doing.

SHRI SITARAM JAIPURIA: On a personal explanation.

SHRI A. B. VAJPAYEE (Uttar Pradesh): What has Mr. Jaipuria got to do in this respect, to make a personal clarification? The question was not addressed to him.

THE DEPUTY CHAIRMAN: You have not heard him. Let us hear him, hear whatever he has to say.

SHRI BHUPESH GUPTA: Can I make a statement in this House about my uncle?

THE DEPUTY CHAIRMAN: I have allowed him to make the statement.

SHRI BHUPESH GUPTA: You can allow him but it must relate to the business of the House.

SHRI SITARAM JAIPURIA: It does, because the question was there.

SHRI BHUPESH GUPTA: This is rather strange. We put a question to the Minister. The Minister gives replies. If a clarification is to come, it should come from the Minister or somebody connected can write a letter to you and it is for you to decide whether the letter should be read out or not. If you allow him to make a statement because of certain questions relating to some of the things in which he may be interested, then, Madam Deputy Chairman, there will not be an end to it. Everyday we should seek your permission to make statements in relation to matters in which we are interested, arising out of certain questions.

DIWAN CHAMAN LALL: May I draw your attention once again—and the attention of my learned friend—to the fact that he does not seem to have read the Rules of Procedure governing this House? I am going to read out this particular rule for his benefit. The rule says—

"203. A member" Any

Member—

". . . . may, with the permission of the Chairman • -."

That is, with your permission, Madam—

". . . . make a personal explanation although there is no question before the Council, but in this case no debatable matter may be brought forward, and no debate shall arise."

SHRI BHUPESH GUPTA: I do, Madam Deputy Chairman . . .

DIWAN CHAMAN LALL: I suggest to my learned friend . . . (*Interruptions*). I am not giving way to Mr. Bhupesh Gupta.

THE DEPUTY CHAIRMAN: Let us listen to him. You should listen to the other . . .

SHRI BHUPESH GUPTA: I will not allow him to pass. I said . . .

DIWAN CHAMAN LALL: I say that there is no debate arising out of this matter, and if my learned friend wants to raise a debate, he cannot do so under this rule.

SHRI BHUPESH GUPTA: I do not know. I want to raise a point of order or whatever it is. The hon. Diwan Chaman Lall is an experienced parliamentarian. Therefore, I listened to him very carefully.

SHRI A. B. VAJPAYEE: Experienced parliamentarian.

SHRI BHUPESH GUPTA: Experienced undoubtedly he is. I concede that point. He said, a personal explanation. I know the truth. I know the rule that I can ask your permission to make statement on personal explanation. I cannot seek your permission to make any statement I like. I cannot, for example, seek your permission to make a statement as to how my uncle is getting on at the race-course. That is not the point. (*Interruptions*).

AN HON. MEMBER: He is a Rotarian.

(*Several hon. Members stood up.*)

THE DEPUTY CHAIRMAN: One at a time.

SHRI SITARAM JAIPURIA: I hope that I will have a word to say.

SHRI BHUPESH GUPTA: If it is your contention that the personality of Mr. Jaipuria is involved in this matter, directly or indirectly . . .

SHRI SITARAM JAIPURIA: It is.

SHRI BHUPESH GUPTA: Just a minute, Mr. Jaipuria. for goodness sake . . . then, you are certainly entitled to allow him to make a statement and I can assure you,, Madam, that I should certainly be all in favour of giving the Member a. chance to clarify the personal situations and positions. But how does it come in here? (*Interruptions*). There-are so many Members of the Rotary Club.

THE DEPUTY CHAIRMAN: Mr. Akbar Ali Khan.

SHRI AKBAR ALI KHAN (Andhra Pradesh): I think Mr. Jaipuria is involved in this indirectly, he being a Rotarian. As such, according to the explanation of Mr. Bhupesh Gupta, he has every right to give a clarification. (*Interruption*).

SHRI BHUPESH GUPTA: Whenever a statement is made against the Communist Party, as a member of the Communist Party, I will always think it right . . .

(*Several hon. Members stood up.*)

THE DEPUTY CHAIRMAN: You may sit down. I am on ' my feet. When I am giving chance to every one by turn, it is very unseemly that so many Members should be on their feet. Mr. Mani, what do you have to say?

SHRI A. D. MANI (Madhya Pradesh) : On a point of order. Mr. Jaipuria's case comes under Rule 203. He happens to be the only unfortunate exception in this House of being: a Rotarian. (*Interruptions*).

SEVERAL HON. MEMBERS: No, no.

SHRI BHUPESH GUPTA: No, no. We suspect that there are many others.

SHRI A. D. MANI: People are asking-him, "What sort of man are you? You are connected with the rotary movement; you are a rotarian", and! he is trying to explain the position.

SHRI ARJUN ARORA (Uttar Pradesh) : On a point of information. Mr. Mani is wrong. Mr. Jaipuria is not the only Rotarian in this House.

SHRI B. K. P. SINHA (Bihar): Madam, I am rather thankful to the hon. Member there, Mr. Bhupesh Gupta, that for once he has taken a correct stand.

SHRI BHUPESH GUPTA: It is a reflection. He should delete the words "for once". In their place it should be "always".

SHRI B. K. P. SINHA: Now, Madam, on many occasions in the past, when there had been question* relating to the Communist Party, the hon. Member had come forward with long personal explanations. I objected on those occasions, but in spite of my objections he went forward with his long explanations. Today he is taking the correct stand but, for this wrong precedent, against the rule, he is himself responsible. All the same I feel his objection is valid today. (*Interruptions*)

THE DEPUTY CHAIRMAN: No more comments. Let Mr. Jaipuria finish his statement.

SHRI SITARAM JAIPURIA: Madam Deputy Chairman, my hon. friend, Mr. Bhupesh Gupta, has been unnecessarily bothering himself. I have already read the extracts from that letter. My point is this. (*Interruptions*). I happened to be one of the past officers of the Rotary International and therefore am personally involved. The movement is an extremely good international movement and it should not be hurt because of certain expressions used here. Therefore I wanted to repeat reading this extract.

THE DEPUTY CHAIRMAN: There is no need to read it.

SHRI BHUPESH GUPTA: It is a notorious fact that . . .

SHRI SITARAM JAIPURIA: As the letter shows very clearly, the editor

of the rotarian magazine has already apologised to the rotarians of India. They have promised to take care that such things are not repeated. They do not ever involve themselves in partisan feelings or propaganda.

SHRI BHUPESH GUPTA: Madam, his last statement is important, namely that the Rotary International has apologised. May we have the communication, the letter or any other document?

THE DEPUTY CHAIRMAN: He has only given the substance in a very short statement.

SHRI BHUPESH GUPTA: That is all right, but he made a very substantive statement.

THE DEPUTY CHAIRMAN: Next item—Statement by Minister.

STATEMENT RE STARRED QUESTION NO. 236 ANSWERED ON THE 5TH MARCH, 1963

MAGAZINES AND PERIODICALS BROUGHT OUT BY THE MINISTRY OF INFORMATION AND BROADCASTING

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI SHAM NATH): Madam, in the course of my replies to supplementaries to Question No. 236 on the 5th March, 1963, I stated that not more than a few complimentary copies of the publicity material (periodicals and journals) brought out by this Ministry are issued. This is the correct position in regard to periodicals and journals sponsored by this Ministry, but in the case of certain other journals, viz., 'Kurukshetra' (English and Hindi), and 'Panchayat Raj' sponsored by the Ministry of Community Development, Panchayat Raj and Cooperation, Yojana' (English and Hindi) sponsored by the Planning Commission and 'Social Welfare' and 'Samaj Kalyan' sponsored by the Central Social Welfare Board, a large number of complimentary
