Installation of Atomic Power Station in Punjab

- 39. SHRI SITARAM JAIPURIA: Will the PRIME MINISTER be pleased to state:
- (a) whether Government have recently received any communication from the Government of Punjab for the installation of an atomic power station in Punjab; and
- (b) if so, what action Government have taken thereon?

THE PRIME MINISTER AND MINISTER OF ATOMIC ENERGY (SHRI JAWAHARLAL NEHRU): (a) A request was received in September 1960 from the Government of Punjab that a nuclear power station may be located in the State. Government of India have not received any subsequent communication on the subject.

(b) A Site Selection Committee was appointed by the Government of India in August 1961 in pursuance of its general policy of the development of nuclear power in India to recommend a suitable site for a nuclear power station in the general area of Delhi-Punjab-Rajasthan-Uttar Pradesh. On the recommendations of this Committee, a site in Rajasthan, in the vicinity of Rana Pratap Sagar, has been selected for the setting up of a Candu type nuclear power station.

The station when completed will also serve the needs of Punjab State.
