SHBI K. RAGHURAMAIAH: Actually we have under consideration the establishment of actual experimental units at high altitudes. It is a question of correlation, a question of coordination and a question of research and examination and that need not be at high altitude itself. The hon. Member will readily agree on that.

SHRI B. K. P. SINHA: May I know why in the opinion of the experts of the Government, Madras was considered more suitable? What are the grounds? Can the hon. Minister give the reasons or the grounds? Or are they also confidential?

SHRI K. RAGHURAMAIAH: Various considerations, Madam, ond one of them, as the House knows, is security and there are other considerations. We are going to have actual experimental research units at various alt -tudes where the work is to go on, and I do not know whether the hon. Member wants me to go more into this.

SHRI A. B. VAJPAYEE: Is it not a fact that no suitable building is available to house the laboratories at Madras?

SHRI K. RAGHURAMAIAH: I am sorry. The information is quite the reverse. The Government of Madras have been good enough f> set aside a floor space of 4,000 square feet for this purpose.

SHRI A. B. VAJPAYEE: Open space?

SHRI K. RAGHURAMAIAH: Built-up space.
