and therefore it meant that the Delhi Milk Scheme, which did not enjoy any special advantage over the other purchasers of milk, provided an assured and more profitable market to the rural areas and thus actually helped the rural producers of milk instead of harming them and the remedy would lie in expanding productivity of milk by better feeding methods and expanding the number of good milch animals there, to meet the requirements of the ghee merchants as well. The deputationists also mentioned that they were representing to the Minis-' ter (Agriculture), UP., who was visiting them shortly regarding loans for m'ore milk animals. Rural dairy Extension Programmes, etc. It has been proposed that to the extent possible De'hi Milk Scheme might not too rapidly expand their drawal of milk from these areas, till the situation improved.
