sector earned profits in 1962-63, it can be inferred, that the costs were lower than the retention prices allowed.

Written Answers

As regards plants in the public sector, the indications are that costs after allowing for full depreciation and overheads are somewhat higher than the retention prices allowed. This is mainly because the capital cost of these plants per tonne of steel capacity is higher than those of the private sector plants which were put up many years ago.

The Universities being autonomous bodies are, however, free to frame their own rules for giving affiliation for post-graduate teaching.

## DRAWING TEACHERS IN HIGHER SECONDARY SCHOOLS IN DELHI

- 301. SHRI V. M. CHORDIA: Will the Minister of EDUCATION be pleased to state:
- (a) whether it is a fact that seme qualified drawing teachers, who are teaching eleventh classes are getting a grade of Rs. 160 while the IMndi teachers who are teaching in middle classes in Higher Secondary Schools in Delhi are getting a grade of Rs. 170; and
- (b) if so, why the drawing teachers are given a lower scale of pay than the language teachers teaching Hindi in middle classes?

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION (SHRIMATI SOUNDARAM RAMACHANDARAN): (a) Yes,

(b) The scale of pay of a post is prescribed after taking into consideration the qualifications, experience, and professional training required to man a post. It is, therefore, not necessary that the scales of pay of drawing teachers and language teachers should be identical. The scale of pay prescribed for the post of a drawing teacher is considered to be quite adequate for the qualifications prescribed for the post.
