COST OF STEEL PRODUCTION

*385. SHRI D H A N A N J O Y MOHANTY: Will the Minister of STEEL AND HEAVY INDUSTRIES be pleased to state what was the cost of production per ton of steel in each of the various steel plants in the country both in the public and private sectors during the year 1962-63?

THE MINISTER OF STEEL AND HEAVY INDUSTRIES (SHRI C. SUB-RAMANIAM): Information regarding costs of production of the Steel Plants in the private sector in 1962-63 is not readily available. But, from the fact, that both the units in the private
