Her record of service and suffering naturally won for her place in independent India's Parliament. She was a Member of the Lok Sabha from 1952 to 1962 and since 1962 a Member of this House. Even during the very brief period of her membership of this House, in spite of failing health, she showed a lively interest in its proceedings and forcefully expressed her point of view on the occasions she spoke. We shall miss in this House a gentle and affable colleague and one who set an example of a high sense of duty.

I shall request hon. Members to rise in their seats and observe one minute's silence as a mark of respect to the memory of Shrimati Uma Nehru.

(Hon. Members then stood in silence for one minute.)

I shall ask the Secretary to convey to the members of the family of Shrimati Uma Nehru our deep sense of sorrow and profound sympathy.
