(e) *Posts and Telegraph Works.*— Orders for the necessary repeater equipment and cables have been placed.

IMPORT AND EXPORT OF RICE AND PADDY INTO AND FROM OKISSA

103. SHRI LOKANATH MISRA: Will the Minister of FOOD AND AGRICULTURE be pleased to state:

(a) what is the up-to-date figure of the total quantity of ricu ar.d paddy imported into and exported from Orissa sinc_e 1st January, 1963; and

(b) the varieties of such rice and' paddy?

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD AND AGRICULTURE (SHRI A. M. THOMAS): (a) A quantity of 35,197 tonnes of rice was imported into Orissa on Government account from 1st January up to 22nd July, 1963. This was supplied from the Central reserve.

During the period 1st January, 1963 to 25th May, 1963, 93,919 tonnes of rice, 546 tonnes of broken rice and 39,583 tonnes of paddy were exported from Orissa to West Bengal on trade account. Export of rice and paddy from Orissa to West Bengal was stopped with effect from 25th May, 1963.

(b) The varieties of rice which were imported into Orissa are Punjab Begmi, American medium and long grain, and fine and coarse varieties of rice procured in Andhra Pradesh.

Variety-wise figures of rice and paddy exported from Orissa on trade account are not available.

WATER TAPS ON STATIONS ON S.E. RAILWAY

104. SHRI LOKANATH MISRA; Will the Minister of RAILWAYS he pleased to state:

(a) the names of railway stations on the South Eastern Railway which hav_e water taps for drinking water; and

RULES FOR CANCELLATION OF SEATS

(a) whether it is a fact that the recently amended rules for cancellation of reserved seats/berths cause hardship to travelling public in third class compartments for journeys within 100 miles; and

(b) if so, whether Government propose to revise the amended rules?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI S. V. RAMASWAMY): (a) and (b) No reservation of seats in III class compartments is generally made *on* tickets for journeys less than 160 kilometres (formerly 100 miles). Reservation of berths/seats is, however, made in III

class two-tier and three-tier sleeper coaches and III class Air-conditioned coaches respectively for journeys less than 160 kilometers on payment of prescribed surcharge, but such reservations are seldom sought and there have 'been no complaints regarding any hardship caused by existing rules relating to them.
