

SEALING OFF OF GHANASHYAM COLLIERY

562. SHRI P. K. KUMARAN: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

(a) whether the management of the Ghanashyam Colliery have complied with the rules before sealing off the Colliery;

(b) how many workers have been rendered unemployed by this closure;

(c) whether retrenchment or lay-off compensation has been paid to the workers; and

(d) if not, what are the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI RATANLAL KISHORILAL MALVIYA): (a) The fire resulting in the closure of the Colliery is reported to be due to the violation of Regulation 118(4) of the Coal Mines Regulation 1957.

(b) 248 workers have been rendered unemployed.

(c) and (d). Retrenchment compensation has not yet been paid to the 82 workers to whom it is due. The matter is under negotiation between the parties.
