THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DINESH SINGH): (a) No specific functions of the Ministry of Defence have been transferred to the Ministry of Economic and Defence Co-ordination.

(b) In procurement of military stores from abroad and securing assistance in building up production capacity, there is more than merely the requirements of Defence to be taken into account. A number of matters concerning industrial capacity in the coun'ry, transport and other facil ties, man-power problems are all involved. It was considered that the Minister of Economic and Defence Coordination, who has been dealing with these problems, shou'd discuss these matters with the foreign governments concerned.
