TRAINS WITHOUT T.T.E.S m RAJKOT DIVISION

•226. SHRI K. S, CHAVDA: Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that some trains are running without Travelling Ticket Examiners in the Rajkot Division of the Western Railway; and
- (b) if so, what is the estimated loss of revenue to the Railways on that Division due to ticketless travel and unbooked luggage?

THK DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI SHAH Nawaz $KHAN r\sim (a)$ Some particularly on less important sections on Rajkot Division are not manned by T.T.E.s daily bot are checked a few times per week.

(b) It is not possible to make a proper estimate of the extent of loss of revenue without conducting a comprehensive ticket checking drive.

SHRI K. S. CHAVDA: May I know, Sir, whether it is not a fact that ticketless travelling and cases of unbooked luggage in the trains without T.T.Es. are increasing? If so, may I know, Sir, what steps the Railway Ministry intends to take in this matter?

SHRI SHAH NAWAZ KHAN: Sir, this question relates particularly to the Rajkot Division. We have carried out checks. We send squads from the Railway Board and squads from the General Manager's Headquarters have gone and carried out surprise checks, and we have found that the extent of ticketless travel in that Division is only 1.7 per cent. We are taking very intensive steps to eliminate even this by having surprise raids in which the Magistrate sometimes has his office nearby so that effective and quick action can be taken. We also go and carry out surprise raids by buses so

that people do not know that checks are coming; they come as a complete surprise. Also by increasing the number of T.T.E.s we are intensifying our checks.

SHRI LOKANATH MISRA: If the surprise checking staff finds out that these are some ticketless travellers even when there are Ticket Examiners or Ticket Collectors, may I know, Sir, if any action is taken against those Ticket Examiners?

SHRI SHAH NAWAZ KHAN: Sir, action is taken against the people who are travelling without ticket. But if we find that ihere is a wide disparity between the surprise checks by the Headquarters staff and the daily checking, then we do take the persons who are working there to task.

SHRI FARIDUL HAQ ANSARI: May I know, Sir, if it Jjias come to the notice of the hon. Minister that, on some railway lines the T.T.E.s have been assaulted; if so, what protection has been given to these T.T.E.s?

SHRI SHAH NAWAZ KHAN: Not only there have been casss of physical assault, but in some cases the checking staff have been physically thrown out of the trains end some of them have been actually murdered. We have approached the State Governments to give us protection. On particularly bad sections, sometimes we send out powerful batches acco"* panied by the G.R.P, or the R.P.F.

SHRI K. S. CHAVDA: May I know, Sir, whether it is not a fact that Rajkot Division is the biggest Division of the Western Railway and the number of T.T.E.s there is proportionately less? If it is so, may I know, Sir, whether the Ministry intends to increase the number of T.T.E.s on this section?

SHRI SHAH NAWAZ KHAN: That matter is under consideration.

श्री श्राहनवाज सां : नहीं, ऐसा तो नहीं है । वे किसी भी स्टेशन मास्टर के हवाले कर सकते हैं ?

श्री ए० बी० बाजपेयी : मेरा निवेदन है कि जरा मिनिस्टर साहब इस बारे में पता लगाएं। यह बात सही नहीं है कि वे हर एक स्टेशन पर क्काको छोड़ सकते हैं। अगर लखनऊ और फैंजाबाद के बीच में किसी मुसाफिर को बिना टिकट पकड़ा जाय तो फैंजाबाद में छोड़ सकते हैं जहां रेलवे पुलिस का थाना है, बीच में नहीं छोड़ सकते हैं।

श्री शाहनवाज खां: जहां ऐसे मुसाफिर बगैर टिकट हों वे स्टेशन मास्टर के भी हवाले कर सकते हैं। कई दफा मैं खुद गया हूं और मैंने देखा है कि बहुत से लोग जो उन के साथ बैठे रहते हैं वे भी उनको उतार कर स्टेशन मास्टर के हवाले कर देते हैं।

SHRI A. D. MANI: Sir, the Minister made the statement that in some cases Ticket Collectors have been murdered. May I know, Sir, if prosecutions had been launched against those who had murdered or is it that those who murdered remained unidentified?

SHRI SHAH NAWAZ KHAN: No, Sir. But when the police can trace out the miscreants, action is taken.

SHRI LOKANATH MISRA: The hon. Minister said that ticketless travellers were handed over to the Station Master. May I know, Sir, if the Station Master has got the power of prosecution? They do not have the police power.

SHRI SHAH NAWAZ KHAN: There are two categories of persons who travel without tickets . . .

Sma A. B. VAJPAYEE: No categories. They are all without tickets.

SHHI SHAH NAWAZ KHAN: . . . some who can afford to pay and others who cannot afford to pay. There are certain people who do not have any money to pay the fine. They are taken off the trains and handed over to the Station Masters.

MR. CHAIRMAN: Till they take the next train!

SHRI K. S. CHAVDA: May I know, Sir, the number of trains running without T.T.E.S in the Rajkot Division?

SHRI SHAH NAWAZ KHAN: The tota! number of trains in the Rajkot Division which are carrying passengers is 154. Of these, 59 trains have permanent staff accompanying them On other trains the T.T.E.s do not accompany every day but every other day or alternately they accompany them.

SHRI A. M. TARIQ: I would like to raise a point of order on this.

Am AGREEMENT BETWEEN PAKISTAN AND CHINA

- *227. SHRI KRISHAN DUTT: Will the Minister of Transport and Commis Tications be pleased to state:
- (a) whether it is a fact that the Government of Pakistan has recently entered into an air agreement with the Government of China; and
- (b) if so, what will be the effects of such an agreement on the security of India?

THE DEPUTY MINISTER IN THE MINISTRY OP TRANSPORT AND COMMUNICATIONS (SHRI AHMKD MOHIUDDIN): (a) We have no information other than what has appeared in the newspaper.

(b) Does not arise.

SHRI A. B. VAJPAYEE: The Minister has just said that he has no other information apart from the newspaper report, but the newspaper says that Pakistan and China have entered into an air agreement and the planes carrying Chinese passengers are to be flown over our territory which the Government has prohibited. May I know what the Government proposes to do in the matter?

MR. CHAIRMAN: But you say that they have prohibited.

SHRI JAGJIVAN RAM: Nothing is to be done at present till an approach is made by the party concerned for giving them the right to over-fly the country. When that approach is made, the requisite steps wiH be taken.

SHRI BIREN ROY: Both India and Pakistan being Members of the I. C. A. O., I would like to know how the Government will deal with the problem of over-flying of any passenger in civilian clothes by the Pakistan air planes unless there is a question of stopping the Pakistani plane on other Indian airports and coming to a head with that country?
