THE MINISTER OF STEEL AND HEAVY INDUSTRIES (SHRI C. SUB-RAMANIAM): (a) and (b) The question of setting up of a steel plant in the Bailadilla-Vishakhapatnam or Goa Hospet regions is being studied in the Steering Group which has been set up to formulate the Fourth Five Plan for iron and steel. It is expected that the recommendations of the Steering Group would be available by the end of 1963. It is too early to indicate capacity, location, date for commence, ment of construction, etc. at this stage.

MACHINE TOOL FACTORY

THE MINISTER OF STEEL AN» HEAVY INDUSTRIES (SHRI C. SUB-RAMANIAM): A Heavy Machine Tools Plant is being set up at Ranchi by utilising a portion of the Credit of Rs. 23:1 crores offered by the Government of Czechoslovakia on the 24th November, 1959. This plant is being designed to produce every year 10,000 tons of diverse types of machine tools in sizes and types different from those which have so far been produced or undertaken by any other agency in India. The Detailed Project Report of the plant has been received and is; under scrutiny.

ACQUISITION OF LAND LYING BETWEEN GANDHINAGAR AND VILLAGE MAN-DA WALI ON PARPATGANJ ROAD

- (b) if not, what is the present position with regard to the acquisition proceedings of this land and by what time it will be acquired; and
- (c) if the answer to part (a) above be in the affirmative, whether Government have decided upon the rate of compensation to be paid to the plot holders there and whether any compensation has actually been paic, if not, by what time the plot holders will get the compensation?

THE MINISTER OF STATE IN THE MINISTRY os- HOME AFFAIRS (SHRI R. M. HAJARNAVIS): (a) No. The land has been notified only under section 4 ot the Land Acquisition Act, 1894.

(b) In accordance with the procedure prescribed in the Land Acquisition Act, 1894, objections filed against the acquisition are being heard by the Land Acquisition Collector.

The Zonal development plan of the area is under preparation and it will take some time before the final notification under section 6 of the Act is issued and acquisition proceedings completed.

(c) The compensation will thereafter be assessed and disbursed to the concerned owners of acquired land in accordance with sections 23 and 24 of the Act.

TRADE COMMISSIONERS/ACENTS OF STATES IN DELHI

- 281. SHRI A. M. TARIQ: Will the Minister of HOME AFFAIR_s be pleased to state:
- (a) the number of States which have deputed a Trade Commissioner and Trade Agent in Delhi; and
- (b) the status given by the Government of India to those Trade Commissioners and Trade Agents?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI R. M. HAJARNAVIS): (a) The deputing of a Trade Commissioner or a Trade Agent in Delhi is the responsibility of the State Government concerned and Government of India have no information in this regard.
