- (b) The allegations relate to closure of establishments and retrenchment, discharge and suspension of workers in West Bengal.
- (c) The State Government have taken suitable action on the complaints. The Central Government have also taken appropriate action on the cases falling under their jurisdiction. Most of the allegations were not established on enquiry.
