- (c) if so, what steps have been taken to check this disease which affects that subdivision every year?

This year, in view of the discussions scheduled to be held in May in Geneva by the Ministers from all GATT Countries and the -breakdown of the negotiations in Brussels between the U.K. and the E.E.C., it has been suggested that the Commonwealth meeting should be at the Trade Ministers' level.
